No. 95-87, as amended, must submit a current program budget three months prior to the beginning of the Federal fiscal year for which a grant will be requested. OSMRE then conducts a detailed analysis of these program budgets and provides a regional recommendation. No estimates were submitted for OK.

³ Consistent with *McGirt v. Oklahoma*, 140 S. Ct. 2452 (2020), and related cases, neither the State of Oklahoma nor any of its agencies are currently eligible to receive development or regulatory grants. *See, e.g., Oklahoma v. U.S. Department of the Interior*, No. CIV-21-719-F, 2022 U.S. Dist. LEXIS 204065 (W.D. Okla. Nov. 9, 2022).
