TOPIC: STATE PROGRAM AMENDMENTS ON CONTEMPORANEOUS RECLAMATION AND TIME AND DISTANCE REQUIREMENTS FOR BACKFILLING AND GRADING.

INQUIRY: Beside Colorado, Utah and Wyoming, are there any states that have submitted to OSM, and then later withdrawn, program amendments on contemporaneous reclamation or time and distance requirements for backfilling and grading?

SEARCH RESULTS: Research was conducted using the Federal Register material available in LEXIS. Excerpts from Federal Register preambles dating from 1983 through January, 1993 that discuss the Director's approval or disapproval of amendments containing the regulations in question are attached, organized by state.
